#### **Program Overview**

The Pharmacy Residency Program (PGY1) at M Health Fairview Southdale Hospital in Edina, MN is a 12-month program consisting of core and elective learning experiences that are tailored to the resident's interests.

M Health Fairview Southdale Hospital is a 329-bed medical center that provides comprehensive medical services in more than 40 specialty services including; cardiology, orthopedics, oncology, obstetrics, neurosciences, critical care, vascular surgery, and emergency medicine. The Pharmacy Residency Program consists of direct patient care experiences in medicine, surgery, critical care, cardiology, and other various specialty areas. Each resident's experience is tailored to individual interests and clinical skill development needs. The program also focuses on the development of leadership, management, and teaching skills. The resident will also work closely with residents at other M Health Fairview sites.

PGY1 Program Purpose: PGY1 residency programs build upon Doctor of Pharmacy (PharmD) education and outcomes to develop pharmacist practitioners with knowledge, skills, and abilities as defined in the educational competency areas, goals, and objectives. Residents who successfully complete PGY1 residency programs will be skilled in diverse patient care, practice management, leadership, and education, and be prepared to provide patient care, seek board certification in pharmacotherapy (i.e., BCPS), and pursue advanced education and training opportunities including postgraduate year two (PGY2) residencies.

#### **Required Experiences**

- Orientation and Training (7 weeks)
- Clinical Management (4 weeks)
- Critical Care (4 weeks)
- Internal Medicine (4 weeks)
- Operations Management (4 weeks)
- Longitudinal Management (Formulary/MUE) (12 months)
- Major Project (11 months)
- Staffing (10 1/2 months)
- Longitudinal Education/ Presentation (12 months)
- One 8-week "core" learning experience resident's choice

This schedule leaves 6 months open for electives.
